#### Internship Programme



Thirty eight (38) graduates have started their one year Internship programme in the Corporation and have been deployed to various departments or regions within REREC. The first batch of 11 interns reported in January while 27 of them started the programme in May 2021.

The Internship Programme is an initiative of the Public Service Commission (PSC) intended to offer youth opportunities to gain practical work experience and/or fulfill the legal requirement for registration by professional bodies. Each intern has been assigned a supervisor and or a coach/mentor to set targets, assign working tools, oversee the day to day work performance and appraise him/her within the existing performance management framework as issued by PSC.

The Interns are entitled to a monthly stipend paid by PSC and a subsistence allowance (catered by REREC) whenever the intern is expected to undertake official duties outside the assigned duty station.


government of Meru at Githongo Sub-County Hospital in Imenti Constituency.

The NCDs examined included high blood pressure, diabetes, obesity and nutrition, among others. Outpatient services for common ailments were also conducted. Those present included REREC Board of Directors Mr. Alex Chesosi, Mrs. Beatrice Kemei, Hon. Nicholas N. Ngikor and Hon. George Ogalo as well as General Managers Dr. Rose Mkalama and Eng. Esther Ruto.

During a meeting held at the Governor's office, the two parties discussed ongoing and future partnership programmes between the two organisations. The possibility of establishing a solar power plant in Meru County was also discussed.

#### Projects Progress Report

During the week ending 4<sup>th</sup> June 2021, REREC commissioned 21 projects in various parts of the country as compared to 27 projects commissioned in the previous week.

North Rift and Coast regions boast of the highest commissionings to date at 47.1% and 46.1% whilst Western Kenya and Eastern have the lowest at 34% and 29.5% respectively.

The total projects commissioned now stand at 845 while another 174 projects are awaiting either joint inspection, shut down or commissioning

The cumulative number of projects in progress is 1228 out of the 2315 projects that REREC is implementing this financial year.
