The evaluation criteria states “8.Submission of valid Trade License/Business permit (to be verified via scan codes) for the tenderer with Evidence of physical registered office (attach utility bills/ lease agreement /rental payment receipt/ evidence of ownership of the premises)” You are required to submit the relevant permit(s) based on your company’s establishment. If your operations are based at a single location (Headquarters), submission of that permit is sufficient. Where the company has branch offices, permits for the branches may also be provided.

We note that in the tender notice, the mandatory site visit requirement is indicated as “None.” However, under the mandatory evaluation criteria, bidders are required to attach a site visit certificate for the tender for provision of cleaning services for Energy Centers Mweiga Logistics Hub & Pole Yard. We kindly request clarification on this apparent discrepancy and confirmation on whether a site visit is mandatory for this tender.	The Tender Document and Addendum No. 001, as published in the local dailies on 13th January, 2026 and on the Corporation’s website, indicated that a mandatory site visit was to be conducted within the dates specified, in accordance with ITT No. 8.1 of the Tender Document.
4.	Kindly confirm whether specific days are allocated to specific offices, as the tender document indicates the site visit period broadly as 21/01/2025–16/12/2025.	
5.	I am writing to your good office in respect to mandatory site visits to all the centers listed in the tender, to kindly consider extending the date or deadline for the site visits, as the centers are many, and costly to cover in a week's time.	
6.	We are writing clarifications on article MR25 about the Nema County Licenses for the respective counties. Can we write a commitment letter that we will acquire the same if awarded the contract.	Required as indicated in tender document
